

# ALASKA MILITARY YOUTH ACADEMY QUALIFICATIONS

## In order to qualify to apply, youth must:

### 1. Be a citizen or lawful permanent resident of the United States and residing in Alaska?

- Youth must be residing in Alaska and, if under age 18, have a parent/guardian also residing in Alaska.

### 2. Be 16, 17, or 18 years of age on the start date of the cycle?-or- If \*15 years of age, must turn 16 prior to AMYA graduation date.

- Youth may turn 19 while at the academy, but on the start of the cycle they must be 16, 17, or 18\*\* years old.
- -or- those who are 15 must turn 16 prior to AMYA graduation date *\*this is at AMYA Director Discretion.*

### 3. Be in need of your high school education? Youth who have a GED or high school diploma are not eligible to apply.

- Youth must need extra assistance in any of our 8 core components (Academic Excellence, Job Skills, Leadership/Followership, Life Coping Skills, Health/Hygiene, Responsible Citizenship, Physical Fitness, or Service to Community)

Youth may (and are encouraged to) stay enrolled in their current school/schooling program while applying for AMYA, however if youth obtain a GED or High School Diploma they are no longer eligible for AMYA.

### 4. Be physically and mentally capable of completing a demanding program?

- Youth must be able to engage in physical activities with minimal modifications. This includes, walking, running, jumping, push-ups, sit-ups etc.
- Youth must be physically and mentally capable to fully participate in the program with reasonable accommodation for physical and other disabilities. AMYA is not a psychiatric, therapeutic program and is not appropriate for applicants who have received mental illness diagnoses where they may present a danger to themselves or others; when their situation is incompatible with a high stress, high-tempo schedule; or if they require off-campus treatment that would deprive them of full program participation.
- Youth who have received mental health treatment/counseling or had suicide attempts/plans within the past 6 months MUST provide discharge summary and/or letter from mental health/medical professional supporting their attendance.
- Youth with extensive food allergies may not be eligible.
- Able to communicate sufficiently with program staff to participate safely in the program.

### 5. Be free of legal entanglements? (No felony offenses/adjudications, no court requirements for 5 months on campus)

- Not under indictment, or ever convicted/adjudicated of a felony (or any crime that would be considered to be a felony if perpetrated by an adult), and not currently on parole or probation for other than juvenile status offenses or misdemeanors.
- No court requirements for the 5 months youth reside on campus.

### 6. Be willing to be free from the illegal use of drugs or substances, alcohol, and tobacco products during the program.

- Youth will participate in regular and random urinalysis testing, any positive result is reason for immediate dismissal.

### 7. Be a volunteer participant?

- Youth must have a desire to attend.
- Youth cannot be forced to attend by parent/guardian or any other entity.
